CRSPC Mock TRP Workshop to Review Global Fund Malaria Funding Applications, Grant Cycle 7 2-4 May 2023

Background

The mock Technical Review Panel (TRP) will allow countries for comprehensive peer review of GF malaria funding applications as well as reviews by recognized experts facilitating the finalization of the application prior to submission to the Global Fund. The purpose of the workshop is to support countries to develop and submit high quality malaria applications.

This workshop is aimed at countries that will submit their malaria funding applications to the Global Fund by 29 May 2023 - window 2.

Workshop Objectives

The Objectives of this workshop are:

- to conduct both an expert and peer review of Global Fund malaria funding applications from participating countries;
- to increase participant's awareness of what constitutes a good funding application;
- to identify countries that will require additional support to finalize their application;
- to outline the next steps needed to address comments on each country's application and finalize it; and
- to develop an RBM CRSPC strategy (as needed) for providing additional urgent support to countries in the remaining period prior to application submission.

Expected Outcomes

The expected outcomes of this workshop are:

- Recommendations for improving country funding applications
- Country strategies for addressing reviewer comments and finalizing each application; and

 Rapid response strategy for addressing urgent country support needs prior to application submission.

Mock TRP Methodology

A brief update will be presented by the Global Fund team, CRSPC and WHO. Countries will be divided into groups of two to three countries mostly based on the type of the application they submit and language.

There will be an initial plenary session to orient the groups on what will take place during the workshop, to introduce the reviewers guide and to distribute copies of the funding applications.

Countries will then meet in their groups to review other country funding applications using reviewer guides, discuss the applications and provide feedback to each country. A group of experts will review key sections of the funding applications independently. Countries will then prepare a plan for addressing comments brought up in various sections.

Countries to be Invited to Participate

All the countries which will submit their funding requests during window 2 period (29 May 2023) will be invited to participate in this second mock TRP workshop.

The tentative list of countries include: Benin, Burundi, Cabo Verde, Cameroon, CAR, Eritrea, Ghana, Guinea, India, Madagascar, Nicaragua, Rwanda, Sao Tome & Principe, Senegal, Solomon Islands, Sudan, Tanzania, Timor Leste, Togo, Vanuatu, Zambia, Zanzibar and Zimbabwe.
